Our office is open with the following permit counter hours Monday and Thursday 8:30 AM - 2:00 PM and Tuesday, Wednesday, and Friday 8:30 AM - 4:30 PM.

Once the permit has been picked up, you will want to go to MDIA, (25741 Three Notch Rd, Hollywood, MD 20636, 301-884-4547), and apply for inspections.
